Dear Nital S. Gosai,

Hello, Friend,

It would be impossible for You to know how Grate-Full I am to finally have the opportunity to Write You this email. Please try to understand that I have been trying to contact You for over four years and have been up against odds You may find very difficult to believe.

I have a Trust Instrument on file which requires any One who makes an application for a CAET to Give Me Notice of the Application. Presumably this should be True in any CAET application if I am the next of kin to the deceased, though My dear siblings were determined to prove Me otherwise.

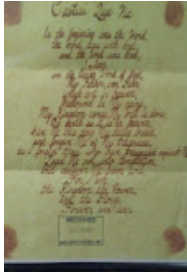
