You expect Me to believe a Court operations SUPERVISOR doesn't know that Court clerks LYING to people about the status of applications and actions before Your Court is fraud? This is perfectly acceptable behaviour and conduct to You?

I tell You that TWO ONTARIO SUPERIOR COURTHOUSES (Ottawa and Bracebridge) are colluding in the fraud, lying to Me about the status of the Certificate and trying to convince Me My sister has been 'duly appointed' when You unbiased and impartial court of Record has no Record of any such event ever taking place, and the \$3 million in claims waiting to proceed against the Estate, makes My sister's Certificate nothing less than EVIDENCE and PROOF of a fraudulent Certificate Issued by THIS COURT. It is shameful that I have to explain to YOU the duties and obligations of court clerks employed under Your watch and explain that harbouring documents and not filing them onto the system is FRAUD and it is a federal, indictable offense, and any clerk involved in such criminal conduct, should IMMEDIATELY be fired, apprehended, and charged to the fullest extent of Canadian Law.

All of this is being published to showcase YOUR incompetence and the incompetence of the Superior Courts of Ontario in general under the treasonous Trudeau liberal criminal organization.

I look forward to hearing from You sometime today. If I don't, I Will presume You became a supervisor of the Superior Court of Justice to maximize Your ability to defraud People and deprive them of their right to participate in the judicial process.
