Dear Madam or Sir,

Opposing counsel in the above Matter have been Noted in Default for their fraudulent testimony in the Estate Application, and for Willful, criminal trespass on a Trust Instrument on file with Canada's Minister of Justice and Attorney General. (see attached)

This request for a Motion to Settle the Order is required to enforce payment. Interest on the principal amount of the Claim does not stop accruing until the fraud (and *the harm being done to Me by this fraud*) is put to a stop, and the outstanding creditors are addressed.

Good Wednesday afternoon to You,

How long does it typically take officers of an Ontario Superior Court of Justice to take action when a federal crime is reported to You for which officers of this Court are complicit, and liable to Me for aggravated harm for failing to guarantee the protect-Sean of My rights according to Canada's Charter, International Law, and the Trustee Act of Ontario?
