Good afternoon, and thank You for Your prompt reply,

Unfortunately, this is unacceptable and You are guilty of fraud in You Notice of Discontinuance because 1070 Hewitt St. is not a valid postal address, none of the parties to the Claim live at 1070 Hewitt St. Gravenhurst Ontario, and Joachim Heinrich von Dehn has been dead since October 19th, 2019.
