I've been cc'ing You on My emails to the Ottawa Superior Court whose clerks are using the Court as a cloak for fraud, serving claims in dead People without legal representation to obtain default judgement in fraud, in violation of the Rules of Civil Procedure and the Rule of Law so that they can bring the default judgements obtained in fraud against an unrepresented Estate to cash in fraudulent insurance claims.
