Good morning, Sir, and Honourable Member of Parliament, Larry Brock,

I come to You in Good Faith and with clean Hands, and I seriously need Your help.

The Ontario Superior Courts are conspiring against Me. My siblings and at least sixteen lawyers representing twelve or more law firms, three Ontario Superior Courts (Bracebridge, Toronto, and Ottawa), and at least four Superior Court Judges, and countless clerks of the Court, are not requiring service of documents on My UNREPRESENTED late father so that they can obtain default judgment against a dead Man, then using the default judgment to draft a new claim again My father's Estate where they are using the default judgment obtained in fraud against an UNREPRESENTED dead Man to proceed with an Insurance Claim against the Estate.

My siblings have been trying to get around a Trust Instrument I have on file with Canada's MOJAG to steal My property, trespass upon My Trust obligations, and engage in Insurance fraud to the tune of over \$3 million. I've reported this to the Ottawa Police, the Law Society of Ontario (but two of their agents are involved and conspirators in the fraud, so they take no action, not in their 'pervu'), the Ontario Provincial Police (they tell Me this is a 'civil Matter', not a criminal Matter), and I can't even get a reply from the three Courthouses involved, they hang up on Me if I call and refuse to respond to email.

I'm only Writing You, Sir, because I Trust My instincts and believe You Will care. I do not believe for one second that any of these shenanigans taking place in Canada's Courts would ever take place under the Right Honourable Jody-Wilson Raybould, and I humbly believe Canada needs to have her back in the position if We do not Wish to see Canada's People lose their Sovereignty to foreign interests.

Justin Trudeau's motive for interfering with Justice in the SNC Lavalin scandal was much greater than just his personal financial interests, it was about making sure that the Honourable Minister was removed from her position so that he could have the Courts to him

Self. In the time that the Honourable Jody-Wilson Raybould has been gone, Canada's courts appear to be completely compromised by foreign interests.

Maybe Arif Virani and David Lametti Will have more to say to You than they do to Me.

"In my over 30 years of experience as a defence counsel and a Crown attorney, I have never heard of any investigation where there wasn't any attempt — whether they agree to interview or not — to interview the person of interest," said Conservative MP Larry Brock."

Honourable Minister, never in My Life did I believe I would live in a county where People are denied their right to participate and even to be informed of judicial proceedings concerning their interests, perhaps one of the most integral Principles of Justice in any free and just society of People.

I do hope and Trust this day finds You well, I really look forward to hearing from You as soon as possible.
