Dear Jove,

I already HAVE!!! Several times. The claim with 'FP' added to the CV number is the first response You Gave Me when I was as King for this information - the FRONT PAGE, NOT THE ENTIRETY OF THE CLAIM!!! It took You TWO MONTHS to get these documents to Me, it DOES not include the Statement of Defense and there is no Record of any Statement of Defense or any events having taken place with any of these claims since the date they were filed!

Why were they 'discontinued' Magically on the same day I am as King for a copy of these Claims? Who were they served upon? You require service of each of these Claims on the parties they are claiming against.

I need to know who is responding to these Claims and why the Court of Record has not been updated with any of the developments. Why is there a Statement of Defense dated **December 8th, 2022?**

They were as King for \$3 million in damages and they just mysteriously 'discontinue' all the remaining Claims on January 4th, conveniently the same day I'm as King for this information?

Good morning!

Well, it's another brand new week, exactly two months after I was as King for service of documents on opposing counsel to the three claims against My father and his Estate, I'm STILL waiting for the disclosure I'm entitled to, and for which these Courts are legally and lawfully obliged to produce unless You are guilty of FRAUD with criminal intent to interfere with Justice.

I'm very curious to know how many People posing as 'State Actors' I Will have to Write before I find some One who Will Honour their Oath to Canada's People. Every single individual and public office in receipt of this email is guilty of serious breach of Trust compounding Crown liability by further aggravating the situation.

How long have the Courts been Acting as a cloak for fraud? Have they also been compromised since 1984? That's how long CSIS claims the Canadian government has been compromised by foreign interests (TREASON).

Once again, the per diem rate for March is \$19,441.85, so take as long as You like. There is nothing unreasonable about the amount of compensation I'm as King for, because every Judge is required to be bonded for the full Value of any Claim they hear, and every lawyer and their firm is obliged to have at least a million dollars liability for breach of Trust and failing to Honour their duties to the public and the Courts.

Twenty-eight million plus six million, twenty-six thousand, nine hundred and twenty-two dollars and thirty-seven cents, is thirty-four million and change, plus another three million for Greg McConnel for stealing My father's ashes, and another five million for Rohit the Sacrilegious Sethi for aiding and abetting insurance fraud and for the defamation of My father's Good Character, framing him for crimes he did not commit to betray his employer, INTACT INSURANCE.

I apologize for the delay but none of You seem to be in any rush, so I thought the first of the month would be the optimal time to provide You with a full accounting of Your liability to Me so far (not including the \$1 million fine for each lawyer, and another \$1 million fine for each firm involved in the fraud).
